I wish to enroll the National Show Horse Registry Lifetime Nominated Stallion listed below in the NSHR Stallion Row Jackpot program. The annual NSHR Stallion Row Jackpot is limited to the first 80 Stallions (75 Stallions & 5 **Diamond Stallions**). If the enrollment form for your stallion is received after 75 stallions have been placed on Stallion Row (**Diamond Stallions** after first 5 **Diamond Stallions**), then he will be placed on the waiting list for the next year.

(Your signature here serves as acceptance of the rules and regulations of the Stallion Row Jackpot Futurity program.)

I acknowledge that my stallion's breeding service will be offered at Auction thru the National Show Horse Finals, with bidding to begin at a minimum of 50 percent of his declared Stud fee, or at an amount I will designate as his stud fee if stallion stands at private treaty. If my stallion's breeding service is sold in accordance with these rules, I will be entitled to one entrant in the Jackpot program/show to be held at the respective resulting NSHR Finals. I agree to provide a "Live Foal" guarantee to the purchaser of my stallion's breeding service. If I desire to do so, I may take my stallion to NSHR Finals to be presented for promotional purposes and agree to pay the NSHR a stall fee and notify the NSHR in writing of my desire by August 15th. If I choose not to take him to NSHR Finals, space will be made available for me for a video presentation and display of promotional literature. If fewer than 8 stallion owners commit to bring their stallion to Finals by August 15th, no stallion presentation will be made. I pledge to do all in my power to promote my stallion in such a way that sale of his breeding service during the Silent Auction is assured. I acknowledge that if my stallion's breeding services are not sold, I am not eligible to place an entrant in the jackpot class. I agree to hold harmless the National Show Horse Registry, its officers and employees, for any injury which might be suffered by my stallion, me or anyone associated with presenting my stallion, as a result of participation in the National Show Horse Registry Stallion Row Jackpot program. I agree to adhere to all rules and regulations set forth for the National Show Horse Registry Stallion Row Jackpot program by the National Show Horse Registry. **Rules: See Stallion Row Jackpot Rule Booklet for complete listing of rules.**

Prior to bidding, bidders must be assigned a bidder number Bidder numbers will be assigned by the NSHR. Each stallion owner participating in the Jackpot (if the breeding is sold) will be permitted to place one foal in the Jackpot competition. High bidders for each stallion's service shall also be permitted to place one foal in the Jackpot competition. Jackpot prize money will be awarded as follows: Champion 30%, Reserve 15%, 10% for 3rd through 5th placings and 5% for the 6th through 10th placings of the monies raised through the Stallion Auction (less administration costs, advertising costs, distribution to SRJ Futurity Programs and cost of awards see **Stallion Row Jackpot Rule Book** for complete breakdown) for the stallions' services. In the Auction for stallions' services, bids will start at a minimum of 50 percent of the stallion's published fee. Winning bids are to be paid in full at the close of the Stallion Auction. Any bidding disputes will be resolved by the NSHR Stallion Row Jackpot Committee. Stallion services not sold at Finals will be offered for sale via mail in bids to the general public through March 31st of the following year at 60% of the advertised stud fee. Services not sold at Finals will be sold on a first come, first served basis. Stallion owners and winning bidders must declare by December 31st in the year the mare was bred, the name of the mare to the National Show Horse Registry. The designated mare as named by the stallion service buyer and/or stallion owner in each case must be owned or properly leased by the stallion service buyer and/or stallion owner at the time of breeding. Designated mares and foals in each instance resulting from the designated mating can be sold by the stallion service buyer and/or the stallion owner, with all Jackpot rights transferred to the new owner. The National Show Horse Registry must be notified of all transfers of ownership in writing within 30 days following the transfer of ownership. The stallion owner agrees that in the event the mare designated by the stallion service buyer or the stallion owner does not bear a live foal for the resulting Jackpot competition as testified to by a licensed veterinarian, the designation will carry over to the next year's competition at no additional fee, but money expended for the original service fee will remain a part of the original Jackpot. The designation may be transferred to another mare, following written application and submission of documentation to the National Show Horse Registry. However, participation in the program as the result of the original service purchase shall not extend beyond one additional year.

The stallion owner may, if he/she desires, outbid other bidders during the Silent Auction for his/her stallion's services and thus place two offspring in competition. Stallion owner agrees to provide the NSHR with a breeding contract prior to Finals. Jackpot competition for foals of designated mares will be held at the NSHR Finals the year following the breeding year with one class, combining sexes, unless participation warrants splitting the class. There shall be no entry fee for the competition NSHR Finals Judges will judge the Jackpot class. Eligible foals must be registered with the National Show Horse Registry at the time of Jackpot competition. Mail-in bids for the Stallion Auction will be accepted through August 31st prior to Finals and placed on file with the National Show Horse Registry.
