Foal to be born in 20__ will be eligible to be shown as a weanling in the Stallion Row Jackpot Weanling Auction class at the NSHR Finals that same year.

The National Show Horse Registry must be notified of all transfers of ownership in writing within 30 days following the transfer of ownership. NSHR retains the right to accept or reject any nomination. If mare nominated does not remain in foal, a letter from a licensed Veterinarian certifying the mare's loss is required to request a one year rollover. The designation will carry over to the next year's competition at no additional fee, but money expended for the original service fee will remain a part of the original Jackpot. If a licensed veterinarian declares the designated mare to be permanently barren, the designation may be transferred to another mare, following written application and submission of veterinarian documentation to the National Show Horse Registry. However, participation in the program as the result of the original service purchase shall not extend beyond one additional year. By signing above, I agree to adhere to all rules and regulations set forth by the NSHR's Stallion Row Jackpot program.
